Footnotes

2. Total return is the change in value of a sub-account over a given period, assuming reinvestment of any dividends and capital gains distributions of the underlying funds. Average annual returns smooth variations in performance, and are not the same as actual year-by-year results.
3. Inception date refers to the start of investment operations of the underlying funds. The fund prospectuses are available upon request.
4. Based on the seven-day period ending June 30, 2014. Seven-day current SEC yield is a hypothetical rate of return for an investment in the Contract's money market Sub-account(s) over the specified seven-day period with dividends annualized.
