

Footnotes

1. The performance results shown are adjusted to reflect mortality and expense charges, and investment management fees and other expenses of the underlying funds. Actual results would be significantly lower after deducting other applicable contract expenses including cost of insurance, administrative and withdrawal charges. 2. Total return is the change in value of a sub-account over a given period, assuming reinvestment of any dividends and capital gains distributions of the underlying funds. Average annual return is a hypothetical rate of return that, if achieved annually, would have produced the same results over the stated period if performance during that period was constant. Average annual returns smooth variations in performance, and are not the same as actual year-by-year results.
3. Inception date refers to the start of investment operations of the underlying funds. The fund prospectuses are available upon request.
4. Based on the seven-day period ending December 31, 2012. Seven-day current SEC yield is a hypothetical rate of return for an investment in the Contract's money market Sub-account(s) over the specified seven-day period with dividends annualized.
